In 2021, IBM provided JIBC access to the academic version of the i2 Analyst Notebook for our graduate students in the following online programs: Intelligence Analysis, Tactical Criminal Analysis and Cybercrime. A link to the i2 file was embedded in the course section and students were able to click on the link and download to their home computer.

At that time, the i2 Notebook software licence included Ed Tech group and Technology Services, both supported the use of the software.

In late December 2022 Harris acquired i2, and after much work, an academic licence is now available again to our students.

The process will remain the same with Harris providing JIBC Academic licence to the software in form of a file, which we can link in the course for students to download on their personal computer. The term for the academic license once a student has downloaded it onto their computer is August 31<sup>st</sup>.

Regarding personal information, I will need to gather additional information from Harris regarding what happens when a student downloads onto their personal computer – as there is an expiry to the software under Academic Licence, so could it be VPN info?
